For all claims present and future arising out of the business relationship with sales persons, juristic persons under public law or special funds under public law, including exchange and check demand, the sole competent court of jurisdiction shall be the Amtsgericht Steinfurt District Court or the Landgericht Münster County Court.

The same jurisdiction applies if the Company does not have a general court of jurisdiction in the country or changed its residence or usual domicile to out of the country after concluded the contract. In the event of any seller's claims made to the buyer, the court of jurisdiction is the buyer's legal residence.

For all legal relations between the buyer and the seller, the laws of the Federal Republic of Germany shall apply to the exclusion of all others. The UN Convention on Contracts for the International Sale of Goods from 11.04.1980 (CSIG, Federal Law Gazette. 1989 II. P. 588 f) and the Uncitral convention on international drafts and international promissory notes from 09.12.1988 are excluded.

Should any provisions pertaining to these General Terms & Conditions or provisions in any other agreement be or become ineffective, the legal effectiveness of the remaining provisions or agreements remain unaffected.
